Dear CCDF Certificate Program Families and Providers,

This message is to inform you of an important program update. The following changes to our reimbursement rates will go into effect on **July 1, 2022**.

- Increase to maximum reimbursement rates.
- Programs enrolled in Quality-First Star Rating through First Things First may receive additional 10%. Programs that are Nationally Accredited may receive an additional 20%. Contact Alizabeth Philbrick to provide verification.
- Full Time and Part Time services will be still covered ("Full" and "Part" time are determined by the childcare provider).
- Reimbursements will be continued to be paid based on each child's enrollment schedule.
