
2) Monthly program information summaries

a) Health and Child Safety


The Health Services Team transitioned children files to archive and completed reviewing children's health data prior to the first day of school. Twenty-one children were in need of a Health Care Plan for a nutritional need such as food allergies, a prescribed meal or food intolerance or sensitivity. The Health Assistants also began to review immunizations for newly enrolled and returning children and determined that a dozen children were in need of updating immunizations prior to the first day of school. When school began, two children were brought up to date and 10 remained delinquent (6 EHS and 4 HS). Those 10 children are provided 15 days grace period from the first day of school to be brought up to date on immunizations.

In reviewing the data from health care packets (enrollment), the Health Services Team have been entering important data regarding medical and dental home into Power School software. In addition, parents completed a "permission" form and that data is also being entered into Power School.

Based on the review from the data of the data in July, a determination was made on child health status for Early Head Start. Based on data, 39% of Head Start children are up to date on a schedule of well child care, 69% of children are up to date on a schedule of oral health care, 44% have a documented lead screening and 57% have a documented hemoglobin screening.



Based on the review from the data of the data in July, a determination was made on child health status for Head Start. Based on data, 25% of Head Start children are up to date on a schedule of well child care, 59% of children are up to date on a schedule of oral health care, 34% have a documented lead screening and 54% have a documented hemoglobin screening.



The Health Services Team plan to conduct a raffle to promote the collection of important screenings, exams and follow-up.

On July 27th, 2023 the ECEC held a Welcome Friends event (Theme: Family Circus) and Health Services focused on completing lead/hemoglobin screenings and vision screenings. Twenty-two lead and hemoglobin screenings were conducted by SRPMIC Public Health nurses as well as 22 vision screenings conducted by River People Health Center Optometry department.

The Health Office required five children to visit the health office prior to returning to school due to fever (2), head lice (2), and rash (1). Only two children were sent home due to fever. No contagious illness notices were sent home to families.

b) Child Education and Development

Family services coordinator and education specialist planned PFCE training for the 2023/2024 school year. The admin team finalized the annual PD plan. ECEC will focus on curriculum fidelity in the upcoming year. A Creative Curriculum trainer will conduct three-hour sessions to increase knowledge of the curriculum over the course of the year.

Education specialist, family involvement specialist, and family serves coordinator, met with community library to plan, "lunch and literacy." Lunch and literacy is a monthly event held on literacy days inviting a member of the community/library to conduct a reading for children and families. Literacy resources will be provided to families to increase early childhood literacy within their home. Families will be invited to join their child for lunch following story time.

On July 28, staff participated in a full day PD day. Team building and TIE were provided to staff. Staff participated in a culture training that reviewed the community's core values. Classroom staff attended, "Classroom Structures Series; Safe keeper's Box, Kindness Tree-Making to increase social and emotional development skills in the classroom.

Teachers completed family home visits/orientations prior to the new program year beginning. The education team met to plan TEPOT and TEPITOS and CLASS observations in the upcoming program year. TEPOT and TPITOS observations will be conducted for each classroom in August to measures implementation of teacher practices in social and emotional development. CLASS is an observation tool that measures a teacher's instruction during a single classroom observation visit.

Preschool teachers continued to use studies from creative curriculum to drive child investigation and learning outcomes. Infants and toddlers used creative curriculum for infants and toddlers and two's used 2's resources.

During the month of July 2023, the Behavior Intervention Counselors (BICs) provided 7 Professional Development opportunities including a continuation of Conscious Discipline structures, Mental Health Services updates, Mental Health procedures, Behavior Incident Report system and helped organized team building and Reflection Walk activity. The BIC focused heavily on collecting, entering the ASQ-SEII's (Social Emotional Screenings), scanning, logging the submissions and returning them to classroom teachers. The BIC's offered support to teachers who will share referral or monitoring information to the families from the ASQ-SEII scores. The BIC's provided additional support to classrooms as they set up their safe spaces and Active Calming Center for the new school year. The BIC's reviewed and updated the ECEC Challenging Behavior process flow chart and shared with staff members during professional development. The BICs shared the department data and facilitated a focus group during Self-Assessment that took place at ECEC. The BIC's continue to participate in the Leadership Team meetings, BEE's committee meetings and the Education Team meetings. The BIC's provided a tour of ECEC to the staff of the San Carlos Reservation. The BIC's toured the Behavioral Health department at River People Health Center and met with staff to review the referral process.

During the month of July, BIC's received 4 Behavior Incident Reports from classroom staff and started the process to consult with staff in order to support children and families. The BIC's also completed 3 consultation sessions with a guardian and offered one referral to Behavioral Health. BICs provided 28 consultations for classroom staff members with focus on teaming, setting up classroom and social emotional issues.

During the Month of July, The ESS Staff focused upon supporting the families with transitions: children exiting ECEC to Kindergarten, new and incoming children, as well as the ongoing referrals. The preparation for the SY 23/24 included a file review, plus the set up for new and incoming children.

Since the Mesa Public Schools (MPS) Itinerant Staff were out due to summer break, the remaining ESS staff completed the ongoing classroom visitations and supports of those children attending at ECEC. Additionally, classroom staff began the required 45-day developmental screenings. ECEC utilizes the Ages and Stages Questionnaire (ASQ-3) Developmental Screening tool for this purpose.

The current enrollment numbers for children identified ESS total 22: 3 children with an IFSP, and 19 with an IEP. Again, due to the summer break at Mesa Public Schools, evaluations were limited until the staff returned on contract, July 17, 2023. At that time, two children completed screenings with scheduling for their full Evaluations. Two additional children transitioning from Part C to Part B services are scheduled for their appointments closer to their 3rd birthday.

Staff provided daily transportation for a McKinney-Vento eligible family. As a team Family Services staff met to do a review of the CPS reporting process and how to assist ECEC with making a report. The team also met with ERSEA staff to review the recruitment plan drafted for the upcoming school year. Family Advocates met to review FPA info and organize data from the "Parent Interest Survey". Staff began planning for parenting workshops and topics for Talk About Tuesday. Family Advocates did a tour of several Community programs that families are often referred to. Staff helped teaching and health staff provide reminders to families who needed to complete orientations or submit immunization records. Family Advocates entered updated court documents into the sharepoint system. However, the system is not sending out email reminders to relevant staff. IT was notified about the issue. Interviews for the Family Advocate position were completed. Another round of "Mandated Reporter" training was offered to ECEC staff. The Family Services Coordinator met with front desk staff to review information about their role in CPS reporting and Social Services visitors. Family Services Coordinator compiled information to present for the ECEC Self-Assessment. Staff participated in a variety of meetings and trainings during the preservice week. Staff also assisted with the Family Circus Night welcome event, where we had families of 75 children attend the event. Home Based families were referred to

School & Community Relations, Benefit Coordinators and Higher Education. Parent Educators began planning socializations for the new school year. Staff also had to update the home visit planning forms. Partners for Healthy Baby discontinued use of their online documentation records. The ECEC Enrollment Technician filled Home Based vacancies for the new school year, there were seven returning children and thirteen vacancies to fill. All slots were filled for the new school year.

July 2023 is our 9th month of under enrollment. We are at 100% enrolled for Head Start and 84% enrolled for early Head start. We need to open 2 Early Head Start Classrooms. We need to a hire a minimum of 7 Early Head Start staff to be able to open the classrooms.
